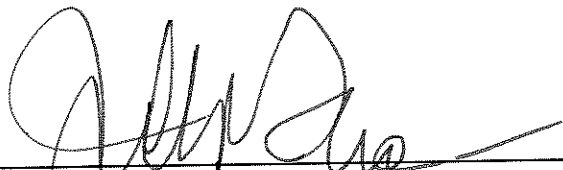
By a unanimous vote of 5-0 the sign request was approved.
